The Ohio Environmental Protection Agency's Water Pollution Control Loan Fund has awarded Columbiana County \$200,000 in Financial Assistance for the Repair/Replacement of Failing Household Sewage Treatment Systems. These loans will receive principal forgiveness subsidies that do not require repayment. This program will pay 50%, 85% or 100% of the cost of a septic system with the homeowner responsible for 50%, 15% or 0%.

The Columbiana County Health Department is seeking bids for 4 projects. All pre-bid paperwork can be found on our website at <http://www.columbiana-health.org> or at the health department for \$10.

Pre-site evaluations have already been performed. All plumbing containing sewage (ie. Laundry, sinks etc) shall discharge to the sewage system which may require additional plumbing permits and work being performed by licensed plumbers. Site visits by contractors are required prior to bidding.

The deadline for submittal of bids is July 17, 2018 by 4:00pm.
